# Fundamentalists win Tennessee textbook case

GREENEVILLE, TENN. (AP) Fundamentalist Christian children
HAVE the right not to read schoolbooks their parents find
offensive, a federal judge has
ruled, in the case of seven
families who objected to such
texts as "The Diary of Anne Frank"
and "The Wizard of Oz".

U.S. District Judge Thomas G. Hull, in a 27-page opinion, said the Hawkins County school board must accommodate the families' rights to a free, public education without violating their First Amendment rights to religious freedom.

He did not recommend a specific alternative, but said home schooling for reading classes would be one.

Hull said he would convene a jury to decide damages in the case and set a tentative trial date for Dec. 15.

Within hours of the decision, the school board's Greenville attorney, Ronald Woods, filed a notice of appeal with the 5th U.S. Circuit Court of Appeals in Cincinnati, said court clerk Irene Keasling.

"This is a wonderful victory. We're ecstatic," said attorney Michael Farris, who represented the parents in their battle for an alternative to using the Holt, Rinehart, Winston series of reading books.

But Anthony Podesta, president of People for the American Way, which paid the fees for Timothy Dyk, the school system's attorney, called the ruling a "recipe for disaster for public education that will disrupt education for all children."

"It will invite every sect in the country to pick and choose which parts of the public school curriculum it will accept," said Podesta, whose group was organized by television producer Norman Lear.

The school board, backed by attorneys from the state of Tennessee, argued during the trial that the changes demanded by the parents would defeat public education's purpose of exposing students to varying viewpoints.

"This is not the end of the road," Dyk said during a news conference. "We intend to take this case as far as is necessary to get this decision reversed."

The case was referred to as a modern version of the 1925 Scopes "monkey" trial in which science teacher John Scopes was prosecuted by the state for teaching Darwin's theory of evolution in Dayton, Tenn. - 150 miles down the Tennessee River from Greeneville.

In Dayton, William Jennings Bryan and Clarence Darrow argued bitterly over whether students could be taught that man was descended from the same ancestors as the apes. The verdict went to the creationists, but was reversed in Scopes' favor on appeal.

The familles had sued the Hawkins County schools in 1983 after objecting to hundreds of passages in the Holt books, including storles by Margaret Mead, Isaac Asimov and Danish fairy-tale writer Hans Christian Anderson.

The parents said the books contain references to witchcraft, exotic religions, one-world government and relative ethics.

They objected to "The Diary of Anne Frank" because its young Jewish author, who died in a Nazi concentration camp, calls for toleration of all religions.

"The Wizard of Oz" was deemed objectionable because it tells children that traits such as courage, intelligence and compassion are personally developed rather than God-given, and the story depicts a witch as good.

Said Hult, "The plaintiffs have sincerely held religious beliefs which are entitled to protection under the free exercise clause of the First Amendment and which are offended by certain recurring themes in the Holt series."

"In forcing the plantiffstudents to read from the Holt series or to forfeit a free public education, the defendants have burdened the plaintiffs' right of free exercise of their religion," said Hull.

He said the fact that Tennessee laws mandate education while allowing children to be taught at home or in private schools shows that the state has acknowledged alternatives to traditional public education in classrooms.

"The plaintiffs are therefore entitled to opt out of the Hawkins County public school reading program while still enjoying the benefit of the rest of the curriculum (with appropriate CONTINUED ON PAGE TEN

# And the Gay vote was missing again

The 1986 election results are now history. There will be talk for some time to come about how the results will affect the Gay and Lesbian community but the fact that the Lesbian and Gay voters did not go to the polls in any significant numbers in, Arizona at least, is true. It seems I've either heard or written that story before!

Each candidate who made a positive statement concerning Gay rights was defeated soundly. It makes us look very bad to politicians in our state, who are aware that we are present, but who now wonder what our impact on local and state government really is. We seem to speak loudly but when it comes to 'carrying that big stick' which we need to effect our political clout, we turn out to be wimps.

No longer will we be perceived as a 'force to be reckoned with' in our state until we show we can elect officials who will be sensitive to our needs.

Realizing that the only political organization that sent questionnaires to local politicians, (the State Committee For Progress), was out of the chute for the first time and maybe could have done more, given more experience and time and money. The two Arizona Gay newspapers each gave Gay and Lesbian voters the pick of the crop of politicians who maybe don't like us, but realize that we are human beings who need redress before the local and state governments. The candidates were clear-cut. Their policies each and every one of them was on 'our' side. In well over 50% of the cases these candidates went down to defeat by large margins - not even close.

It makes one wonder if the Kinsey figures are true. One in ten! Pima County voting officials claim that only 52% of the registered voters turned out for this years election. So obviously 1 in 10 did not make it to the polls in Pima County. The statewide figures are not in at presstime but it is probably a like percentage of non-voters.

To Carolyn Warner, Richard Kimball, Mike Morgan, Diane Bishop and the others running unsuccessfully for the various state legislative offices, please accept our sincere apologies. We tried to raise the consciousness of our community and we have failed.

To Morris Udall, Jim Kolbe, Renz Jennings, Diane Bishop and the other successful legislative candidates for state office congratulations on your victory. I am sorry that we cannot accept credit for your victory, for we are not sure that anyone in our community voted.

There were a couple of good notes in this election day of defeat for the Gay community: Rep. Trent Franks (R-Phoenix) was defeated by a stim margin and the voters in California defeated the LaRouche Proposition 64 by a whopping 70 plus percent. The initiative called for identification of AIDS victims and possible quarantine measures. It would have barred them from education and restaurant employment. Virtually all major candidates, the Gay community and the California medical establishment opposed it. The California Gay community is obviously much better organized politically than is our Arizona community,

In these times of ultraconservatism, fundamentalism, and plain haired and fear of Gays and Lesbians because of the AIDS crisis, we have to hold hands and keep our goals on a path that permits us to show our strength in united numbers. Only then can we achieve our common goals in the only viable manner - the political process.

# Massachusetts linemen return to work with man dying of AIDS

NEEDHAM, MA (AP) - More than two dozen telephone repairmen who had walked off the job rather than work with a colleague dying of AIDS relented last week after talking with doctors about the fatal disease.

But four others refused to enter the office they share with the diseased man and had to be handed their assignments outside.

"It's not that they don't like Paul," said Kay Moore, wife of shop steward George Moore. "They think their families are in jeopardy."

The Moores were among 50 workers and their families who met with three doctors to talk about their fears of contagion from Paul Cronan, 31.

The repairmen returned to work after a yearlong absence and the settlement of a \$1.5 lawsuit against the New England Telephone Company. The suit alleged the company revealed his disease to co-workers, provoking threats. The amount of the settlement was not disclosed.

Cronan, who lives in Boston, said he was greeted on his first duy back at work by a message scrawled on the garage wall: "Gays and bisexuals should be taken to an island and destroyed." The sign was crased.

The next day, 29 of Cronan's 44 co-workers refused to pick up work orders at their office.

The meeting with doctors allayed most fears, although they trivialized families concerns, Mrs. Moore said.

She said most of the families were not aware that doctors believe that acquired immune deficiency syndrome is a virus spread through sexual intercourse

EARLY SEX EDUCATION URGED IN SURGEON GENERAL

REPORT ON AIDS

LOS ANGELES, CA (AP) - Sex education should begin in early grades so children will know how to protect themselves from AIDS, Surgeon General C. Everett Koopsays in a report on the deadly disease, the Los Angeles Times has

Koop's report, which was issued last Wednesday, also says that acquired immune deficiency syndrome should not be used as an excuse for discrimination, the newspaper said.

Sex education "must start at the lowest grade possible . . . so that children can grow up knowing the behavior to avoid to protect themselves." the report said.

"Thee is now no doubt that we need sex education in schools and that it include information on heterosexual and homosexual relationships," Koop wrote. "The need is critical and the price of neglect is high. The lives of our young people depends on our fulfilling our responsibility."

The Times, quoting unidentified sources, said the report was presented to President Reagan earlier this month and was approved by the White House.

The report was quoted as saying that quarantining patients "has no role in the management of AIDS because AIDS is not spread by casual contact."

"AIDS should not be used as ity through legislation or other is an excuse to discriminate against means; any group or find vidual, "Koop wrote.



Conservative Cardinal Joseph Ratzinger, head of the Sacred Congregations for the Doctrine of the Faith, instructed bishops to stamp out pro-homosexual views within the church and to oppose any attempt to condone homosexuality through legislation or other means.

# Blacks. Hispanics far more likely to get AIDS

WASHINGTON, DC - Blacks and Hispanics account for four out of 10 AIDS cases in the United States and are far more likely to get the deadly disease than white Americans, according to a report released last week by the Federal Centers for Disease Control.

"Blacks and Hispanics are being disproportionalely affected by the epidemic," said Dr. Harold Jaffe, chief of the CDC's AIDS epidemiology program. "In minority populations, AIDS is a disease particularly affecting male and female intravenous drug users, their sexual partners and their children."

"This issue has been largely inappreciated. The stereotype of AIDS is that it's a disease of middle-class white men. That has prevented people from seeing it as also a minority health problem," said Jaffe.

The CDC report noted that of the more than 24,500 cases of AIDS reported in the United States in the last five years, about 6,200, or 25 percent, were black and about 3,500, or 14 percent, were Hispanic. Yet blacks comprise only 12,0 and Hispanics 6 percent of the overall U.S. population.

Some communities were hardest hit, with about two-thirds of all black and Hispanic AIDS cases in New York, New Jersey or Florida.

Once they get AIDS, blacks and Hispanics may also die of the disease more quickly than whites, said Dr. Beny Primm, a black physician who heads the Addiction Research and Treatment Corporation in Brooklyn. He said that minority AIDS victims are often "debilitated when they come in, so bothered by so many health problems, wait so late to get help, and cannot get proper health care."

The new CDC statistics show that among adult AIDS patients, the majority of cases are still among white homosexual and bisexual males. But looking at rates per million people affected, blacks and Hispanics are more than three times as likely as whites nationwide to get the disease.

There were also sexual differences. Men of all races account for over 90 percent of all AIDS cases. Of more than 22,000 male AIDS patients, 37 percent were black or Hispanic.

But among the 1,600 women who have contracted AIDS, 70 percent have been black and Hispanic women, making them about 12 times more likely to get AIDS than white women.

In terms of risk of getting AIDS, CDC found that homosexual or bisexual men with AIDS were predominantly white, while "patients with a history of IV drug abuse or

heterosexual contact with persons at increased risk for acquiring AIDS\*\* and those with unknown risk factors were predominantly black or Hispanic.

Minority children with AIDS have also been particularly hard hit. Of the 350 AIDS cases in children under 115, 58 percent have been black and 22 percent Hispanic. The national incidence among black children is 15 times greater than that among whites and among Hispanics, nine times greater, CCC said.

Again, these children were more likely to live in New York, New Jersey or Florida. Most of the children with AIDS acquired the disease before or during birth from the mothers who were IV drug abusers, or whose sex partner was a drug abuser.

The disease, which is spread through Intimate contact with blood or bodily fluids, has not been shown to be spread to older children within households by casual contact.

Both Jaffe and Primm emphasized the need for more recognition of the minority AIDS problem and more targeted education programs. Primm believes that the "black community is in somewhat of a state of denial that this could not necessarily be a problem for blacks."

# paper makes AIDS test a hiring factor

BIRMINGHAM, ALA (AP) - The Birmingham News has been requiring new employees to take AIDS tests because of health and financial concerns, s the newspaper's publisher said.

The practice was begun about six months ago, Victor H. Hanson II told National Public Radio.

"We don't want knowingly to get involved with somebody who has a debilitating illness that would be very costly to us," Hanson said.

While the AIDS test is a condition of employment for new workers, the newspaper is not requiring those hired before the policy was implemented to take the test.

The blood test reveals the presence of antibodies to the AIDS virus. It does not indicate whether the virus itself is present or whether the person will develop the fatal ailment, and health officials say it can produce incorrect results.





TUCSON - The Tucson-based Center for Human Development is scheduling another eight-week Men's Support Group beginning in January, 1987. The program is not a counseling or therapy group, but rather an opportunity for married Gay men to explore the issues that are central to healthy adjustment and optimum personal functioning. The format of the series Includes a weekly one-hour meeting; each of the eight meetings focuses on a specific issue for discussion and provides an opportunity for the participating men to share their ideas, feelings, needs and suggestions regarding the week's topic. No formal presentations are planned. Following each meeting those men who wish to continue the relationshipbuilding, frequently get together for coffee, drinks, etc. at another location to continue the evening's session, and the group may continue beyond the planned eight-weeks If the participants wish.

The support group operates on the premise that each man's marital and Gay status is a highly individual and unique matter. As such, each man must decide (1) Whether he wishes to work toward sustaining and strengthening the marital relationship or instead to move toward dissolution of the marriage; (2) Whether to come out to his wife (and/or family) or to keep his homosexual interests and activities covert; (3) Whether he will be open to, or insulated from, the possibilities of an emotional, affectional relationimplications of that decision; (4) How he can best cope with the feelings of resentment, confinement, guilt, ambivalence, etc. that can occur as he tries to express his full sexual and emotional self and still maintain

the expected marital role; and (5) How he will cope with the desire for Gay sexual outlets and the interpersonal and health issues that can arise.

During the eight weeks, the participating married Gay will have a positive, self-enhancing opportunity to explore and examine his values, beliefs, sexuality and capacity for personal intimacy. All matters relating to the group are discreetly managed and confidentiality is assured.

Although the Men's Support Group is limited to approximately eight-ten men each session, two concurrent groups are planned. The only eligibility requirements are that the participant must be (1) Gay or bisexual and (2) planning marriage, currently married or recently separated or divorced. Any man who is interested in the remaining openings may contact Dr. Dan Overbeck's office, himself a formerly married Gay counselor, at 884-0476 for additional details. Meeting dates and times will be scheduled once the participant roster is full, and will, as much as possible, be at the convenience of the participants.



or contact with blood and blood products.

A few of Cronan's colleagues have been turned away from their friends' houses because of widespread misunderstanding about AIDS contagion, she said.

Others are under pressure by their families to stay away from Cronan, and some families simply don't believe the doctors' assurances.

Yet the families were impressed by the phone company's resolve to keep Cronan on the job, and by his persistence, Mrs. Moore said.

"The majority of people were saying they admired Paul and his courage," she said. "They understand he's a human being and he's suffering from something nobody has control over."

Business agent Mike Connor said the local chapter of the international Brotherhood of Electrical Workers was supporting Cronan's return to the job because "it's the right thing to do."

Cronan's attorney, David Casey, who handled the case for the American Civil Liberties Union, said the company promised to refuse service to customers who wouldn't allow Cronan in their homes.

New England Telephone spokesman Peter Cronin said he was checking whether that was a provision of the settlement, but the company has received no complaints. HOPE EXHAUSTED TO UNITE LOVERS

Even though Thompson and Sharon Kowlaski had been lovers for four years at the time of the accident, Kowalski's perents eventually obtained court orders giving them absolute custody of their daughter and refused to allow the two to be together or for Thompson to continue physical and occupational therapy to which Kowalski was responding. Kowalsky has regressed without the therapy and has little chance of regaining even rudimentary motor skills if: it is not resumed. Thompson's attorneys said that they may have exhausted one of their last hopes to reunite the women.



provisions for home instruction according to state law)." Hull said.

"I can say I'm very grateful and I'm thankful," Frost said by telephone from her Church Hill home.

Hull noted that trial testimony showed using alternative texts in class would be burdensome to the school system.



# New sex research project underway

PHILADELPHIA, PA - Word of a new study focusing on Lesbian and Gay sexuality has been released by two independent researchers. The study seeks to address the question about the types and incidence of sexual disfunction in Gay and Lesbian couples. James Bahr, a member of the research team, stated, "We believe that Gay and Lesbian sexual orientation is a natural state. Further, we believe that Lesbians and Gays should be sexually functional. Very little research has been done on sexual disfunction in Lesbian and Gay couples. The work that has been done has exclusively focused on couples who have come in for counseling. Clinicians need information desperately. Moreso, Gays and Lesbians who are sexually disfunctional, or have a disfunctional partner, need to know that they are not alone.

The researchers hope to be able to answer what most sex researchers consider to be a basic question: "What kinds of sexual disfunctions affect couples and how prevalent are they?" Bahr notes that It was as recently as 1979 that a similar study was first done on heterosexual couples. This study proved invaluable to sex researchers and clinicians who need to treat the disfunctional couples.

Now, Bahr and Dr. Gerald weeks are beginning to ask the same question about Gay and Lesbian couples, in hopes of helping to "normalize" Lesbian and Gay sexuality, as well as to provide important information. "For too long now," Bahr points out, "Lesbians and Gays have been viewed by the scientific community as emotionally underdeveloped, or sick. This attitude is reflected in, and partially directed by, the

research done. The time has come for research concerning Lesbians and Gays to begin to reflect and explore our issues."

Bahr, who is himself Gay, recalls, "I have had to deal with disfunctional Gays and Lesbians in the past whose confusion and lack of knowledge about sexual disfunction has caused them a great deal of anxiety. All I had to offer them was my knowledge of heterosexual disfunction. It seems appropriate that when dealing with a particular population a clinician or researcher should have knowledge about that population. Extrapolations from other populations are not sufficient,"

Currently, the study is in the data collection stage. Weeks and Bahr are trying to obtain couples willing to fill out their questionnaire. The questionnaire takes 15-20 minutes to complete. and is returned via mail. Participants will have no contact with the researchers, unless so desired. Bahr assures that all information is anonymous and confidential; no one will be able to identify a couple with their responses, not even the researchers. Nothing else will be asked of the participants. Length of the relationship is not a consideration; that the partners consider themselves to be in a committed relationship is all that is required. The only couples who should not fill out the questionnaire are those that have ever been in counseling as a couple. Couples where one or both partners have been in individual counseling are encouraged to participate.


